## 5 VERSION NUMBER EXPLANATION

RATEX products follow this version numbering convention: *Major* version, *Interim* version, *Hot Fix* change, each separated by a period. For example, the third release of the first version is numbered like this:

**19 (Major) . 3 (Interim) . 11 (Hot Fix)**

What each number represents is illustrated in the table below.

Table 2 RATEX Version Numbers

Release Type	Major	Interim	Hot Fix
Frequency	12-18 Months	3 Months	As needed
Contents	Major new features	Feature Enhancements	Program fixes without feature change

**Note:** Security changes are made in Hot Fix releases, and all Major and Interim releases include these security updates.

**Note:** RATEX does not use wildcard versioning numbers. All version updates are inclusive of previous version updates, including previous security-impacting changes.
